Report On Attendance at the Funeral of Master Sergeat Clint R. Marshall, (USA, Ret.), Former Platoon Sergeant, Recon Platoon, Delta Company, 2d Battalion - 8th Cavalry, 1965-66



Clint Roger Marshall died February 10, 2008 at age seventy nine. He had been ill for a while, but well looked after by medical personnel, friends and family. He died in Snyder, Oklahoma southwest of Oklahoma City, where he had been born and raised and where he had spent his life when not stationed elsewhere during his 22 years in the Army.

An older brother who served in the Navy during WW II was killed during the landings on Okinawa, when a kamikaze struck his destroyer. Clint enlisted in the Army in 1948 at age 19, completed infantry basic and advanced individual training and jump school and was then assigned to the 82d Airborne Division at Ft. Bragg. He later served with the 101st Airborne Division at Ft. Campbell and also in Korea and Germany. He married a hometown girl, Jo Ann Hines, and they had seven children: Connie Jo, Jamie Dee, Betsy Ann, Ginny Lynn, Cindy Lou, Roger Lyle and finally Jay Dalton who died in infancy.

Clint and I met in early 1965 at Ft. Benning when we were the Platoon Sergeant and Platoon Leader respectively of the Recon Platoon, Company D, 1st Battalion - 511th Infantry, 1st Brigade, 11th Air Assault Division, soon to be redesignated Company D, 2d Battalion - 8th Cavalry. We hit it off immediately. While I would leave the platoon in June 1965, I remained in the company as XO for another eight months and so we remained close. He would spend some eighteen months as the Recon Platoon Sergeant including the unit's first year in Vietnam.

On leaving Vietnam in the summer of 1966 we were both assigned to the 82d Airborne Division at Ft. Bragg although in different brigades and saw each other occasionally over the next year. I have a vivid recollection of having been invited to dinner at the Marshall's home in Fayetteville and of their three youngest children there. I was reassigned after a year and we lost touch for the next forty one years. He retired from the Army in 1970. He used to tell people that when he was leading he had never lost a man.

Thanks to the Angry Skipper Association, (Henry Cruz, Skull, 1970-71), I obtained Clint's phone number and called him in November of 2007. He was not feeling well but was at home and we had two long and very satisfying talks on the phone. He sounded exactly as he had over four decades before. We talked over old times and in particular our battle on 4 November 1965 in the Ia Drang Valley. (After Action Report posted at http://angryskipperassociation.org/) I discovered that his first wife, Jo Ann Hines Marshall, had died in 1987 and that he had remarried. His wife Reba and I spoke on the phone. She and Clint had known each other since childhood. We planned to link up at the Angry Skipper reunion in Salt Lake City in May 2008.

Clint's condition got worse over the winter and I resolved to go to visit him. Reba and I spoke several times but I never again spoke to Clint. I did not get there soon enough. On arrival in Oklahoma City the morning of February 11th, 2008 I called Reba who told me he had died the day before.

I drove to Snyder and visited with his family and friends at Clint's casket that afternoon. His family welcomed me with open arms. I was introduced to several men and women who had known Clint all his life. I knelt by his casket and offered a prayer. We adjourned later to the home he had built near a lake north of town.

On February 13th, following a well attended church service, Clint was buried with full military honors in the cemetery where his mother lies. The cemetery is in an area of low hills and red granite. Many of the headstones are of that material, as is Clint's. It was a beautiful sunny clear day on the plains. The burial detail, firing squad and bugler artillerymen from Ft. Sill to the east - performed with crisp precision.

Reba had asked me among others to speak at the graveside. I pointed out the importance of the platoon leaderplatoon sergeant relationship, said that Clint Marshall had had the magic of small unit leadership, marveled at the gift that small-town-America continues to provide the nation's military by way of its sons and daughters and finally suggested that if our national leadership did half as well as Clint Marshall had, the nation would be far better off than it is.

Afterward, the family and some friends and neighbors returned to Clint's and Reba's home by the lake and we talked and remembered late into the night.

There was an explosion on 2May69, followed by a brief firefight in which Neil Brown was killed. Top grabbled two of us, John Lee (Range, 68-69) and myself, to carry Neil out of very thick bush. As a cherry I could barely walk with my own stuff, but John and I managed to get him out of there.

In 1998, at the Charleston reunion hosted by Jim (Skull, 68-69) and Nancy Nix, I heard John talking about how hard it was to get Neil out and something about a damn cherry helping him when I confessed it was me. (John & I did not know each other in Nam) Since then, John and I have paid our respects to Neil and the others at the Wall in D. C. When we voted to go to Salt Lake City, both of us wanted to see if we could find Neil's final resting place, as we knew he was from Salt Lake City.

The internet showed us he wasn't in a national cemetery, so John and his wife, Jan, hit the records places in Salt Lake City and we finally found a good lead. We went to the Utah State Archives just after it closed on Friday. We got the guard to come over and he gave us a phone number of a Viet vet who worked in that office. He said his vet buddy might be in Saturday from 9 to 1 p.m. I called him while on the bus to Park City and 2 minutes later had the address and directions to the cemetery where Neil was buried.

On Sunday morning Al Seal (Range, 71-72), Dirk Olson (Skull, 71-72), Everett "Corp" Tolbert (Skull, 69-70), John Lee and I found ourselves doing a grid search in a cemetery until we found Neil (the grave locator office was closed). Corp said a nice prayer and we all paid our respects to a fallen brother. I don't know why, but I'm proud of the fact that we got him out of there and to say goodbye to him here.
